UK Government Approved

The Carbon Saver GOLD Standard enables organisations to robustly demonstrate, to their stakeholders, both a commitment and an achievement of reducing carbon emissions.

UK Government Approval

"The decision to approve the Carbon Saver Standard follows extensive consultation by the Environment Agency with businesses, the public sector and a wide range of environmental groups."





Requirements

To achieve the Carbon Saver GOLD Standard organisations must:

- ✓ Accurately measure their Carbon Footprint electricity and gas consumption and any onsite fuel use (e.g. heating oil, diesel, etc.)
- ✓ Achieve a reduction in Carbon Emissions either an absolute reduction in emissions or a 1.75% per annum relative reduction (e.g. tCO2e per £ turnover, tCO2e per employee, etc.)
- Evidence Effective Carbon Management provide evidence that the organisation has effective carbon management practices (e.g. policies, procedures, etc.)



Assessment

- Independent assessors will review the applicant organisations against these criteria
- Successful applicants are awarded the Carbon Saver GOLD Standard
- In the case the applicant is unsuccessful on the first attempt, a Carbon Saver Action Plan will be prepared
- The organisation will then be re-assessed in 6 months time on a complimentary basis





Remove Duplication - Other Schemes

A demonstration of compliance with other schemes that require similar evidence will be sufficient to achieve compliance with the relevant sections of the Carbon Saver GOLD Standard e.g.

- ISO14001
- ISO14064
- ISO 50001
- PAS 2060
- GHG Protocol

- CDP Disclosures
- Carbon Trust Standards
- Other industry specific standards
- ESOS & other third party audits
- SECR & other third party verification
